#### **Payment Plans**

Any homeowner who is unable to pay assessments is entitled to make a written request to the management company for a payment plan to be considered by the Board of Directors. Homeowners may also request to meet with the Board in executive session to discuss a payment plan. Payment plans may incorporate any assessments that accrue during the payment plan period.

Payment plans shall not prevent CHOA recording a lien on homeowner's property in order to secure payment of delinquent assessments. Additional late fees shall not accrue during the payment plan period if the homeowner is in compliance with the terms of the payment plan. In the event of a default on any payment plan, CHOA may resume its efforts to collect the delinquent assessments from the time prior to entering into the payment plan. The Board will consider payment plan requests on a case-by-case basis but is under no obligation to grant payment plan requests.

#### **Delivery Thefts**

Thefts of packages dropped off at homeowners' front doors have been recently reported. If you are expecting a delivery from a commercial carrier, such as FedEx or UPS, you might want to confirm delivery with a signature or make arrangements for a neighbor to be on the lookout. ## Children Playing in Common Areas

Parents: Please tell your children NOT to play in the planter areas or to climb trees in the common areas. With spring's new growth, blossoms and leaves are especially vulnerable. Flowers and shrubs are paid for and planted by CHOA, and replacing these plant materials costs extra. Treeclimbing is also a liability issue.

#### **Barking Dog Complaints**

Orange County Animal Care, which serves Cypress, has a procedure to follow to report barking dogs. To qualify as a nuisance animal, a dog must be barking nonstop for 30 minutes or more in any 24-hour period, or barking off and on for 60 minutes or more during any 24--hour period.
