#### Know the Rules!

To be a responsible homeowner, you must be fully knowledgeable about the rules and regulations by which CHOA is governed. #### Here are a few reminders:

#### □ NO Bounce Houses.

Recently, a bounce house was rented for a private party. This is **NOT** permitted (liability issues) under CHOA's Rules & Regulations and is a violation meriting a fine. The party was held on the common area, and this is also a violation. CHOA maintains two clubhouses for homeowner private parties.

#### □ NO Charcoal BBQs.

Gas grills are permitted, but **not** charcoal BBQs, due to an open fire hazard with the wood fences.

□ **NO Skateboarding** in common areas and alleys.

## Larwin Avenue Project

The City of Cypress will be working on slurry sealing many streets and will begin on Larwin Avenue, in April, with concrete work first, repairing sidewalks, curbs, and curbcuts. Slurry sealing of the street and alleys is scheduled for the end of May.

The contractor will be distributing construction notices two weeks prior to construction. All parking restrictions will be posted 48-hours in advance, and door hangers will be distributed to all affected residences and businesses.

Do NOT drive on the slurry seal until it cures (about 4 hours after it is applied). Streets will be opened to traffic once the slurry has had adequate time to cure. If all goes as planned, they will be opened by 5:00 p.m. e a c h d a y . www.ci.cypress.ca.us/public works/street rehab.htm.

# Satellite Dish Installation – Do It Right!

Many homeowners are installing satellite dishes improperly. Homeowners will receive a violation letter and will be billed (and prompt payment expected) for stucco repairs/painting and/or roof repairs resulting from improper installation of satellite dishes.

Architectural approval is required prior to installation of a dish Architectural forms can be downloaded from www.cypresshoa.org (or call Yamy at 949-581-4988, ext. 275) and should be submitted at least 10 days prior to a Board meeting. See below a picture of a properly installed dish.
