2022 ASSESSMENT INCREASE

The Board of Directors approved the 2022 Operating Budget back in November 2021 to begin January 2022. All owners were mailed and emailed the budget packet informing them of the increase in assessments. If you have not already done so, please update your assessment payments in your autopay system whether it be through your personal bank or the HOA bank (Sunwest Bank). Management does not have the ability to adjust this for you. Please note, assessments are due on the 1st and late on the 15th. You have been charged a \$20.00 late fee if your account is delinquent, or you are carrying a balance. All fees are noted in the collection policy for the Cypress Home Owners Association, which was included in the budget mailer. It is important for homeowners to make their payments on time so that the Association can maintain its financial obligations.

TRASH ENCLOSURE MAINTENANCE

Due to the large number of bulky items that are left in the trash enclosures daily, the HOA must continue to pay for an additional refuse service in the amount of \$1,560/month, which doesn't include the regular refuse service which averages in the amount of \$5,000. On top of that cost, if construction materials are left in the enclosure, CHOA is required to pay additional fees for their disposal. The Board and Management are asking that you be courteous to your neighbors by disposing of items in the dumpsters and do not leave the bags on the ground. Please breakdown all cardboard boxes before placing in the dumpster. If you or your contractor is reported dumping construction materials into the trash enclosures, your assessment account could be fined, and you could be liable for the cost of the disposal.



Pets can be a wonderful addition to your family, but please remember that as a pet owner, you are responsible for all your pets including cats. You should make sure that your four-legged friend does not become a nuisance to other residents. Kindly please remember to pick up after your pet when walking the Cypress Home Owners Association common area grounds.

Besides being unsightly and smelly, animal waste can be hazardous to the health of our children who play in the community and other pets. One of the most common forms of disease transmission between dogs is through fecal matter. By taking a few simple steps to clean up after your pet, you can contribute not only to the beautification of our community, but also towards the elimination of one of the most irritating nuisances in our community. CYPRESS DRUG TAKE BACK DAY — SATURDAY APRIL 30TH 10AM-2PM

Cypress Police Department hosts a collection site set up in the department parking lot where residents can safely dispose of any unused or expired prescription drugs. If you don't properly dispose of the unused or expired prescription drugs in your home, they might find a new one.

- Unused or expired prescription medications are a public safety issue, leading to accidental poisoning, overdose, and abuse.
- Pharmaceutical drugs can be just as dangerous as street drugs when taken without a prescription or a doctor's supervision.
- Most teenagers abusing prescription drugs get them from family and friends and the home medicine cabinet.
- Unused drugs that are flushed contaminate the water supply. Proper disposal of unused drugs saves lives and protects the environment.
