ANNUAL MEETING, ELECTION OF BOARD OF DIRECTORS

CHOA's Annual Meeting and Election of the Board of Directors is **Wednesday**, **February 21**, **7:15** p.m., **Clubhouse #2**. Homeowners should have received their ballots in the mail already. Please read the instructions carefully to make sure you have filled out your ballot and return envelope correctly so your vote counts. To reach quorum, 126 ballots must be received. If there is no quorum, a second attempt must be made at a subsequent meeting. This results in extra costs to CHOA, which means YOU.

TRASHY COMMUNITY

The Board voted for extra trash pick-ups the week before and the week after Christmas. Even so, trash is strewn on the ground inside and outside of the trash enclosures. DO NOT place any trash, of any kind, on the ground inside the enclosure. If you have bulky items that need picking up, call the Community Service Manager, Beatriz Borja, 949-581-4988, extension 274, to arrange for Valley Vista Services to pick-up these items. Place them OUTSIDE the trash enclosure in a manner that does not obstruct the gates of the trash enclosures or traffic, and mark them for Valley Vista Services.

WE WANT TO HEAR FROM YOU

Our CC&Rs are in need of updating to comply with current law. There will be a Town Hall Meeting in March, to consider some important changes. Two important items to be addressed: 1) continuing with trash bin areas vs. personal trash containers for each unit, and 2) the need to restrict rentals in our community.
