Trash Reminders

The trash enclosure doors have just been painted, and new latches have been installed. The new signs for the doors have been ordered and will be installed later this month.

We would like to provide some reminders regarding the trash throughout the community.

- 1. Please be sure to close the door and lock the latch after use.
- 2. Please do not park your vehicle in front of the trash enclosures. This prevents the trash companies from being able to pick up the trash. Your vehicle can be towed without warning if it is parked anywhere in the alley that is not a valid parking space.
- 3. All trash needs to be placed in the dumpster. If the dumpster is full, please find another dumpster to dispose of your trash. Vally Vista will not pick up any trash that is on the ground.
- 4. Please take pride in the community and do not leave bulky oversized items in the common area for disposal. This is an eyesore for all residents and is against the Rules and Regulations of the community. Did you know?

The asphalt alleyways located throughout CHOA are not maintained by the Association. They are owned and maintained by the City of Cypress. The asphalt alleyways are considered fire lanes and this includes in front of the trash enclosures. Vehicles not parked within a designated parking space are subject to being towed by Cypress PD, without warning. Please be sure to follow all parking rules within the community.

- 2. No pets or animals are permitted in the clubhouse (service animals excepted).
- 3. No alcohol at any time.
- 4. No one under the age of 21 years is permitted the use of the clubhouse without supervision at all times by an adult at least 21 years of age.
