Greetings. Good news on our property/liability insurance policy that the Board renewed with Farmers Insurance. Our premium decreased by almost \$10,000! This savings will help balance our budget.

The homeowners appointed to the Painting Committee at the last Board meeting are Holly George, Megan Kaplinsky, Beth Paul, Jean Redfearn, and Elizabeth Winger. They will assist the Board in color selection and scheduling. The Board has met with the painting contractors and will vote on their selection at the July meeting.

Mandatory water rationing was implemented on July 1 by Golden State Water Company. To conserve water, the Board voted to replace the older sprinkler heads with rotating nozzles. The cost of these will be offset by rebates and reduced water consumption.

### **Sewer Rate Increase**

The City of Cypress is initiating a major capital improvement program to replace the city's aging sewer system. If approved by City Council, the new sewer rate will increase to \$0.77 per CCF of water usage from \$.014 per CCF, effective Sept. 1.

This will impact our CHOA budget because the water meters for the pools are included in this rate increase. Fortunately, the meters for irrigation are <u>not</u> included.
