## **Emergency Preparedness**

When is the last time you checked your smoke detectors to see if the batteries were dead? Take five minutes now to go through your home to test them. Smoke detectors should be tested every six months, but it's easy to remember to test the batteries when daylight savings time starts in March and ends in November.

Most of the homes in our community are two-stories tall. If your home is a twostory model, what would you do if a fire on the first floor made going down the stairs and out of the doors impossible? Jumping out a second story window is not anyone's first choice. Consider an escape ladder, which "stores compactly, deploys quickly, and keeps you prepared for the possibility of fire and other emergencies." Most escape ladders attach to windows, are tanglefree, and stretch out to form a flameresistant, durable, and sturdy ladder.
