BREAK DOWN BOXES!

CHRISTMAS TREE RECYCLING

Valley Vista Services will collect Christmas trees after December 25 through the third (3rd) Saturday in January. Please strip your Christmas trees of all decorations, tinsel, garlands, and remove tree stands. Flocked trees will NOT be accepted. Place trees on the curb lawn, NOT inside the trash dumpsters. Thank you!

PROJECT UPDATES

Many of you have already noticed that our complex is in the process of being painted. Weather permitting, this should take about three (3) months. Part of the complex has had a problem with tree roots invading sewer pipes and causing back-ups. The Board has contracted to have all the sewer lines in the 4700 and 4800 blocks hydro-jetted to remove tree roots. This has also required the installation of cleanouts (the builder never installed them) to access the pipes. And lastly, just in time for the holidays, the Board purchased all new chairs and tables in both clubhouses.

CC & R REVISION

The Board is seeking volunteers to help revise the CC & Rs in 2018. There are several items that need updating, in addition to some new items unforeseen fifty (50) years ago when the CC & Rs were originally written.
