22	Purpose of the Meeting
23	The Chair announced that the purpose of the meeting was to elect five (5)
24	candidates to the Board of Directors for a one (1) year term.

26	Inspector of Election
27	David Cane, Robert Kaplinsky and Carl Kroll were introduced as the Inspectors of
28	Election duly appointed by the Board.

30	Announcement of Quorum
31	David Cane announced that a quorum had been obtained with one hundred forty-
32	three (143) sealed ballots received.

34	Proof of Notice of Meeting
35	Management submitted an affidavit of mailing as proof that Notice of the Meeting
36	was mailed to the Membership.

38	Reading of the Minutes of the Preceding Meeting
39	David Cane addressed the Membership and requested a motion to read or waive
40	the reading of the minutes of the previous annual election meeting. A motion was
41	made and seconded to waive the reading of the Minutes. The motion carried
42	without opposition.

44	Reports of Committees
45	There were no Committee Reports.
46	
47	Election of Directors
48	The declared candidates were introduced to those in attendance.
49	
50	Nomination of Candidates from the Floor
51	At this time the Chair opened the floor to nominations of candidates. There being
52	no nominations of candidates from the floor, a motion was made and duly
53	seconded to close nominations. The motion carried without opposition.

55	Presentations by the Candidates
56	The candidates present declined their invitation to make a presentation at this time.

58	Voting Procedures
59	Management explained the voting procedures involving cumulative voting.
60	Homeowners may cast their votes all for one (1) candidate or cast up to five (5)
61	votes for each candidate. No fractional voting is permitted.

63	Balloting
64	The Membership was asked to cast their ballots and deposit them, in the official
65	sealed envelopes, with the Inspector of Election.
66	Following casting and collection of the ballots, a motion was made and duly
67	seconded to close the balloting. The motion passed without opposition.

83	Tamara Honegan (Incumbent) received 128 votes
84	John Russell (Incumbent) received 174 votes

87	121 Votes For
88	15 Votes Against
89	7 Vote Abstaining

91	David Cane, Inspector of Election, announce that Maria Delvaux, Judith Fischer,
92	Tamara Honegan and John Russell received the highest number of votes and were
93	duly elected to the Board.

95	The proposal for the IRS Revenue Ruling 70-604, 75-370 and 75-371 passed by
96	majority vote.

100	made and duly seconded to adjourn the Annual Membership Meeting at 8:45 p.m.
