Pools & Clubhouses Remain Closed Due To COVID-19

The CHOA Board of Directors is committed to ensuring the safety and health of all homeowners. Therefore, CHOA's pools remain closed, in accordance with the State of California's restrictions and guidelines. Even though chlorine kills the virus, the social distancing required to keep people apart when they are out of the water would necessitate hiring a pool monitor. In addition, the cost of continual cleaning of the pool, gate handles, restrooms, etc., would be prohibitive. A special assessment would be required. Our clubhouses also remain closed. Clubhouse #1, closed for a long time due to water leak and mold, will be repaired and ready to rent in the fall, when gatherings in the clubhouses may be permitted to resume.

Effective August 1, CHOA's management company will be La Perla Property Management, owned by Yamy Criblez. Yamy was CHOA's property manager several years ago when she worked with Accell. She has since opened her own management company, La Perla. More details will be forthcoming.
